NOTE IF YOU ARE GOING TO MAKE YOUR OWN TRANSPORTATION ARRANGEMENTS: Note that airlines are now changing flight times regularly and sometimes cheaper flights become available to the club, therefore the shuttle to the resort will be adjusted accordingly to meet the club's airline schedule, regardless of other member's flight times. If you book your own flight AND you want to ride on the shuttle from the destination airport to the resort (and return to the destination airport), you must arrive at the destination airport and be ready to load the shuttle BEFORE it departs (and ride on the club's shuttle back to the airport regardless of your flight schedule). Under no circumstances will the shuttle wait on you to arrive (or for the return trip, leave earlier or later than scheduled for the club's return flight). The ski club will not be responsible for providing or paying for a separate shuttle to the resort. It is strongly encouraged that before you decide to make your own air arrangements, that you include the cost of ground transportation, as you may not be able to use the club's shuttle.

## AGREEMENTS

#### **BUS or Shuttle**

If financially feasible and we fly out of Atlanta, the Chattanooga Ski Club may arrange for round-trip bus transportation from Chattanooga to the trip origination airport (ATL) if enough trip participants agree to participate. By my signature below I agree as follows (**check one**):

I will pay for my share of the cost of the round trip bus ride up to a maximum of \$120 MAX. PRICE by September 1st, 2023. I understand that this cost is nonrefundable because the bus has to be booked early and the club would have to recompute the per person cost of the bus every time someone cancels.

I plan on getting to the origination airport on my own by other means. I understand that if I ask the trip leader for permission to ride the bus back to Chattanooga (e.g. if the return flight is rerouted to a city other than the original departure airport), and further if I pay the trip leader for my share of the cost of that bus ride (as determined by the trip leader) before that bus departs, I will then be allowed to ride that bus.

#### **RELEASE OF LIABILITY AND HOLD HARMLESS**

I understand that the **CHATTANOOGA SKI CLUB** is a voluntary association operated by volunteer officers, trip captains and board members who have no professional training in the leadership organization of ski trips and related activities. I release the Chattanooga Ski Club, its officers, its board members, its trip captains and its members from, and agree to hold them harmless from any liability in connection with the trip. I agree for myself, my heirs, executors and administrators to waive any claims or rights against them and not pursue any legal action against them, for any harm, loss, personal injury whether mental or physical, or death suffered by me in connection with the trip, including without limitation all transportation, accommodation, skiing and social activities. NOTE THAT THE SKI CLUB IS NOT RESPONSIBLE FOR ANY CHANGES IN PRICES FOR ANY PART OF THE SKI PACKAGE PROVIDED BY THE VENDOR, INCLUDING LODGING, FIGHTS, LIFT TICKETS, EXCURSIONS, ETC.

I acknowledge on behalf of myself and all minors of whom I am parent or legal guardian, that participation in the Trip may be potentially dangerous. I know that there are risks and dangers involved, and I hereby assume all of the risks, known and unknown, of participation. I also hereby agree to abide by the trip rules of the Chattanooga Ski Club. I am signing this document granting this release and am participating in the Trip, voluntarily.

#### **CANCELLATION POLICY**

The Drop Date or the date by which I must cancel and get any refund is November 1st, 2023.. Even before the Drop Date I understand that I will be liable for (1) any fees charged by the resort and/or transporter(s) as a result of cancellation, and (2) any increase in cost to the Chattanooga Ski Club resulting from the cancellation. The minimum cancellation fee is \$100. All trip cancellations revert to the club for resale purposes. All credit card fees are nonrefundable.

#### MEDICAL POLICY

I grant permission for the Trip Captain to seek medical attention for all applications named should the need arise and parent/next of kin cannot be reached by telephone after a reasonable attempt has been made.

#### **SUMMARY**
